- Picture ID, W-2 forms and/or 1099s, Social Security Cards (or ITIN) for yourself, your spouse, and each dependent on the tax return
- A voided check or savings account information for direct deposit of any refund
- Totals for medical expenses, contributions, etc. (It is important to have already added up all receipts)
- Employer ID (EIN) or SSN of all childcare providers for child care tax credit
