What to bring: Photo ID for taxpayer (and spouse if filing jointly); Social Security ID or ITIN ID of each person on the tax return; W-2s, 1099s, social security statements (SSA-1099), all documents reflecting earnings; last year’s tax return; all childcare provider names, addresses and employer ID numbers (EIN) or SS numbers; evidence of deductible expenses; Economic Impact Payments received (in 2020 and separately in 2021); income and expenses for sole proprietorship (Schedule C); 1095-A form if you have Marketplace (ACA) insurance; and checking or savings account number for direct deposit of a refund.
